DB updated her report to say that two new applications had since been submitted from Axford

- a treework application at Whiteways
- an application for Hatches House to re-position a chimney and add a dormer window to an east single-storey extension.

The authorities have still taken no action taken re. the enforcement notices.

DB reported on her recent exchange of correspondence with the planners about the most recent traffic survey monitor (installed on 8th July) on Whittonditch Road, with roadworks and contraflow traffic lights in operation close-by from 9th – 20th July. She was pointing out that the data gathered could hardly be a true record of traffic movement or speed in that location, given the circumstances

DB also drew planners' attention to the PC's concern (re. PL/2025/01559) that the ground absorption tests in Upcot Field by the drainage people had been conducted after two months of almost continual drought so would not be a true record of what would happen when the field is saturated, as it is in normal weather.

A response had been received from Eleanor King at the Atlas Planning Group (rather than Wilts CC planners) saying they would "carefully scrutinise the data to ensure it is still robust, and if it is directly impacted by the (traffic) lights we will redo the survey"

6(ii) Finance

Erica Hodgson

- **SIDs** – EH reported that the order would be submitted at the end of August as the installation contractor will be able to take delivery of them and carry out the work in early/mid September.
- **Hedgeworks at Whittonditch play area** – Three quotes have been received. EH gave details of the scope of works and the varying quote amounts. It was unanimously agreed that the lowest quote should be accepted and the work put in hand as soon as possible. **Prop. MT; Seconded DE. APPROVED**
DB and DE confirmed that they would be able to inspect the work upon completion and approve payment of the contractor's invoice.

6(iii) Rights of Way

Doug Greenway

- DGr said there had not been a good turnout for the July circular walk, perhaps because of rain. There was no walk in August
- SG has heard from the landowner re. the dead ash trees on the verge near the Mill Lane ford that he is away till September but will be back in touch then.
- Despite the closure of Footpath 30 councillors expressed their concerns that people are ignoring the notices and still using it. Wilts Rights Of Way Dept. say the repair work to Lofts Bridge will be carried out in September. DGr will get in touch with them to check if an extension to the closure period will be necessary.

ACTION - DGr

2009

- DGr also brought to councillors' attention some proposed changes to the definitive map re. footpaths RAMS 5, RAMS6, and RAMS8C (and Little Bedwyn Path No.20 Diversion and Definitive Map and Statement Modification Order 2025) and whether the PC should be raising objections. He is concerned about the proposed re-routing of those Ramsbury footpaths, which he sees as a worse option than the existing route; he will discuss with the previous Chair of the PC's RoW Committee to get some background to this case, and will draft a response for councillors' comments, before conveying the PC's views to Wilts CC. **ACTION - DGr**
- HL mentioned a tree has come down over a footpath near Crowood Farm, although it is still passable. DGr was asked to let the landowner know. **ACTION - DGr**

6(iv) Play Areas and Seats

Denise Edwards

- The three quotes for the hedge work at Whittonditch play area, to remove overhanging branches behind the swings, along the hedge line and at the surgery end of the footpath had been discussed earlier in this meeting, and the lowest quote had been accepted. (See item 6(ii))
- RoSPA have notified us that their annual safety inspection will be carried out some time in September. That means the timeline is tight for repair and maintenance works to be carried out. **Note:** RoSPA were contacted after the meeting to ask if their inspection could be deferred till the end of September or early October so the new equipment being installed in September could be incorporated into this year's annual report.
- DE is aware that several items of snagging work in the play areas have yet to be completed and are likely to be flagged up in this year's RoSPA report. SG has contacted the contractor for a fresh quote in this regard.
- SG has spoken to Veena Nanda about a memorial bench for Peter, and Veena has kindly offered to purchase the bench and to provide plaques for both the bench and the new picnic table.
- A new octagonal picnic bench has been purchased and was very kindly put together and installed in the community orchard by Paul Gill, with the help of several other councillors. DB expressed the PC's thanks to Gilly and to everyone else who lent a hand.
- No play area problems have been reported elsewhere.

6(v) Emergency Committee

- AF reported that some new emergency wardens have been recruited and only one more is now needed, for the Atherton Close area.
- AF has updated the Emergency Plan and SG is looking at it.
- We await a response to our grant application to SSEN resilience fund for two new generators for our Village Hubs.
- The two CPR training sessions arranged for 25th September are now fully booked.
- MT has been researching new two-way radios. AF will investigate the two-way radios we already have before deciding on any further action. **ACTION - AF**

6(vi) Environment Committee

- MW confirmed the new, 8-seater, octagonal picnic bench had been put up in the orchard.
- Robert Copp has been asked to quote for re-siting the re-cycling bins further back away from the footpath.

Public Forum – Parish Council Standing Orders temporarily suspended for this item

7. AXFORD

DB reported on the neighbourhood meeting held on 13th August with the landowners affected by the trespassing, vandalism and antisocial behaviour happening around the weir. Various ideas were discussed but no obvious practical solution presented itself. **Note: A meeting with Stephen Leonard has since been arranged for 9th Sept. to discuss a possible TRRO order.** **ACTION - DB**

2010

- DB expressed frustration at the bureaucratic difficulties being encountered by the PC in their attempt to get some sort of 30mph reminder signs put up near the Jubilee Field. AF wondered if the minimal amount of street lighting in Axford could really be regarded as “a lighting system” from a legal standpoint, and if that should be regarded as restricting our signage options to such an extent. She will try to look into how that term is defined in law and will report back. **ACTION - AF**
- EH mentioned that a walker with a dog had reported having to be rescued from a field of bullocks in Axford.

8. LOCAL HIGHWAYS & FOOTPATHS IMPROVEMENT GROUP

Alison Foale

- DB read out an email from Steve Hind (Wilts CC Traffic Management, Principal Engineer) on 15th August, detailing “the only realistic location along Union Street” of the tubes for the mooted one-way traffic trial, the initial two-way survey to last one week followed by the one-way survey lasting another week. He estimates the cost of this to the PC would be approx. £450. Any further locations in connection with this trial would involve an increased cost.
There was a lengthy debate about the suggested location of the tubes for the trial, and the wider impact of re-routing southbound traffic along Oxford Street, into The Square and Scholards Lane. AF conjectured that most people from outside the village who use the Crowood Lane/Union Street southbound rat-run towards Springs Hill will soon stay on the B4192 to get wherever they are going. Village residents maybe more likely to turn left at the Crown & Anchor than right into Oxford Street, but that will remain to be seen and is one of the purposes of running the trial in the first place.
It was eventually agreed that, in order to learn if/how the trial might make a difference (a) to the residents of Union Street and (b) to the wider village, the PC would need to be able to compare the data on the volume of traffic in the two stages of the trial. **ACTION - SG**
- As regards the Whittonditch residents’ application for a speed reduction on the B4192, SG had learnt at the LHFIFG meeting on 31st July that 16 other highway applications were currently being prioritised within the Group’s very limited annual budget of £25,246. Their application will remain on the list for future consideration (along with 21 others) but SG notes that the current budget will not cover all the schemes requested.

9. MARLBOROUGH AREA BOARD

SG will attend the next meeting on 30th Sept. NB. Local groups and organisations are reminded to get their grant applications towards the cost of purchase of equipment to Andrew Jack at Wilts C.C. in good time as requests must be in at least two weeks before the meeting.

10. REPORT OF TOWN & PARISH CLERKS’ MEETING ON 26TH JUNE

DB read out SG’s report from the meeting that there was still no action on election costs. There was not much else to report, apart from the Engagement Event happening at Marlborough Library (2-4pm) on 28th August to do with the Wilts CC new 5-year plan consultation. NB. A survey in this regard on the WCC website can be completed at any time.

11. ALLOTMENTS

DE said that the new lease (based on the wording of the old one but with a rent increase as agreed) was still being considered by the landowner’s solicitor and the PC await their response.

12. WEBSITE

- The July traffic report had been circulated.
- SG has been reassured by the website hosts that the unusual increase in international visitor numbers in May and June is nothing to worry about.

13. VILLAGE MAINTENANCE

- See item 6(ii) regarding installation of five new SIDs which will be ordered at the end of August for delivery direct to Brennans. Brennans are able to dispose of the old ones for us. **ACTION - SG**
- The phone equipment has been removed and the PC's adoption of the phone box outside the Memorial Hall is now complete. Redecoration of both phone boxes in the village will be carried out on 3rd/4th Sept.
- SG will contact Luke Barnes when he returns from holiday about the problems his drivers have reported in negotiating the pinch points on Oxford Street where cars are densely parked. They say the problem stems from larger SUVs etc. parking opposite the high walls of The Bell and the adjoining property, as their coach mirrors prevent them from pulling in as close as they otherwise could. SG will suggest that Barnes leaflet the residents about this problem. **ACTION - SG**
- SG has had no response from the burger van people to her invitation to come for a trial period.
